1. PUBLIC HEARING ON ORDINANCE NO. 4561 (AS AMENDED) – AN ORDINANCE TO AMEND THE FISCAL YEAR 2025-2026 BUDGET ORDINANCE NO. 4544, PROVIDING FOR REVISIONS TO THE GENERAL, STATE STREET AID, SANITATION, CAPITAL PROJECTS, GRANTS, AND WASTEWATER FUNDS - FINANCE.

RECOMMENDATION: Conduct the Public Hearing for Ordinance No. 4561 (As Amended).

INFORMATION: This public hearing is related to item 10.2 on the agenda. The proposed ordinance is the first amendment of the FY 2026 Appropriation Ordinance and revises the General, State Street Aid, Sanitation, Capital Projects, Grants, and Wastewater Funds.

Supporting documentation for the amendment is included within the agenda packet and the required Notice of Public Hearing was published in Main Street Maury on September 24, 2025.

This amendment increases the City's total budget for FY 2026 by \$93,367,586 from \$88,953,406 to \$182,320,991.

2. PUBLIC HEARING ON ORDINANCE NO. 4562 - AN ORDINANCE CONVERTING FLOW OF TRAFFIC ON SOUTH GARDEN STREET TO ONE-WAY TRAVEL FROM W 11TH STREET TO DEPOT STREET - DEVELOPMENT SERVICES DEPARTMENT.

RECOMMENDATION: Conduct the Public Hearing.

INFORMATION: City of Columbia Development Services Department was requested to convert the portion of South Garden Street between West 11th Street and Depot Street to one-way in conjunction with a development project at 1205 South Garden Street. Said development is providing the modifications in-kind, including on street parking, pavement markings, and necessary signage. This change was

unanimously recommended for approval by Columbia Municipal Planning Commission on September 10, 2025. The required notice of Public Hearing was advertised September 17, 2025 in Main Street Maury.

INFORMATION: The applicant is requesting approval for a preliminary PUD Master Plan consisting of a multifamily and town-home development consisting of 94 units. This is a reduction from the previously approved plan approved in 2019. The Planning Commission reviewed this request and recommended approval by a vote of 6-0 at the September 10, 2025, meeting. The notice of Public Hearing was advertised on September 17, 2025, in Main Street Maury.

INFORMATION: The applicant is requesting to zone property proposed to be annexed under Resolution No. 25-39 to CD-3 (Neighborhood Character District). The concept plan reflects future development of 31 single family lots. The Planning Commission reviewed this request and recommended approval by a vote of five to one at the September 10, 2025 meeting. Tennessee state law prescribes municipalities to adopt building code editions that are within seven (7) years of current publication. The International Code Council publishes an updated code edition every three (3) years. The City of Columbia has previously adopted the 2000, 2006, 2012, and the 2018 editions of the International Building Codes. The current 2018 edition of the International Building Code was adopted in December of 2019. The proposed 2024 code editions, with modifications, will be effective January 1, 2026, which is within the directed timeframe. The notice of Public Hearing was advertised in Main Street Maury on September 24, 2025.

7.1. APPROVE DISBURSEMENTS FOR THE MONTH OF AUGUST 2025 IN THE AMOUNT OF \$9,023,499.62 - FINANCE.

7.2. APPROVE THE ANNUAL RENEWAL OF CYBER INSURANCE WITH CFC AND PAYMENT OF PREMIUM TO INSURANCE BROKER IN THE AMOUNT OF \$26,925 - FINANCE.

RECOMMENDATION: Approve.

INFORMATION: The City of Columbia’s insurance broker, Redman Davis, solicited quotes and proposals for cyber insurance services. CFC was identified as the vendor providing a consistent level of coverage at the lowest price compared to alternate proponents.

The premium cost for the FY 2026 policy is \$26,925. The cost of insurance in FY 2025 totaled \$24,143. The increase on the margin follows from solicitation of comparative quotes reviewed by MIS and broker. CFC coverage provides four times the coverage per “crime” and a lower deductible (\$10K vs. \$25K per occurrence).

Using MIS data provided to calculate the share of computing devices by fund, a breakdown by fund is as follows:

The City Council is requested to approve the renewal of City cyber insurance with CFC in the amount of \$26,925, the payment made to Sunstar, formerly Redman Davis.

7.3. APPROVE THE CERTIFICATION OF CITY OF COLUMBIA REAL AND PERSONAL PROPERTY TAX ASSESSMENTS FOR THE YEAR 2025 - CITY RECORDER'S OFFICE.

RECOMMENDATION: Approve.

INFORMATION: The City Recorder is certifying and submitting the City real and the personal property tax assessments, for the year 2025, as assessed by Mr. Bobby Daniels, Maury County Tax Assessor.

The real estate property taxes are assessed at \$1,634,602,210 with tax revenue of \$13,487,275. Agricultural land taxes are assessed at \$5,951,950 with tax revenue of \$49,110. The personal property taxes are assessed at \$118,926,264 with tax revenue of \$981,261. The total tax revenue billed is \$14,517,646 and there are 23,796 tax notices. The City tax rate is \$0.8251 for each \$100 of assessed value.

7.4. APPROVE THE BID AWARD AND THE MAYOR TO SIGN AN AGREEMENT WITH COLUMBIA DODGE FOR THE UPFITTING OF PATROL VEHICLES IN THE AMOUNT OF \$14,260 PER VEHICLE - POLICE DEPARTMENT.

RECOMMENDATION: Approve.

INFORMATION: Columbia Dodge Upfitting specializes in equipping law enforcement agencies with the tools they need to protect and serve their communities effectively. They provide and professionally install a full range of police equipment in patrol vehicles, ensuring that every unit is safe, reliable, and mission-ready.

From emergency lighting, sirens, and communication systems to in-car computers, video recording technology, and weapon mounts, Their team delivers turnkey solutions tailored to Columbia Police Department operational needs. They work closely with Government officials, police leadership, and fleet managers to design installations that are both functional and compliant with state and federal standards.

For several years, Columbia Police Department has relied on their services to outfit and maintain their patrol fleet emergency equipment, trusting their expertise to keep their vehicles fully operational.

INFORMATION: The Mule Town Disc Golf Club, based in Columbia, TN, is submitting a request for a Non-Exclusive Use Permit with the City of Columbia to use the Woodland Park Disc Golf Course located at Woodland Park for all of their league, tournament and club events for the 2025-2026 calendar year. In lieu of paying user fees, the Mule Town Disc Golf Club will work closely with the Parks and Recreation

Department to host disc golf events throughout the year and assist with general maintenance of the course.

INFORMATION: City Council approved a contract with Nickell Company on April 10th, 2025, in the amount of \$701,276.50 for the South Main Street and 8th Street Roundabout Project.

Change Order No. 1 addresses a deduction of \$7,223 in the total original contract amount relating to eliminating the removal and replacement of a portion of the sidewalk located in the southwest quadrant of the project, along with infill of the center island retaining wall with concrete, including the forming/pouring of a concrete pedestal for the monument statue.

Change Order No. 2 addresses an increase of \$24,778.09 to the amount of the original contract relating to the removal of unused filter sock and inlet protection, striping removal, and additional milling, paving, and striping down South Main Street.

Change Orders No. 1 and No. 2 increase the total contract price by an amount of \$17,555.09.

INFORMATION: The City of Columbia was awarded funding under the 2025 Waste Reduction Grant Program through the Tennessee Department of Environment & Conservation. This grant was approved by City Council under Resolution No. 25-33 on May 08, 2025. The grant was awarded at 70%, with a local matching fund of

30% from the City of Columbia. The \$297,639.72 grant will offset an amount of \$425,199.60 for a recycling truck. The local match for this project is the difference of \$127,559.88.

Sourcewell purchasing cooperative, has contract #110223-LEG with Environmental Products Group for a 2024 Labrie Automizer side loader recycling truck. Public Works would like to take advantage of this contract.

RECOMMENDATION: Approve.

INFORMATION: The City of Columbia's Wastewater Department requests the mayor to approve and authorize Change Order No.1 between the City of Columbia and Cumberland Valley Constructors, for the Bear Creek Sewage Pumping Station replacement in the amount of \$27,637.81. The changes will include the modifications to the VFD's to allow readings of both moisture and temperature sensors at the pumps and modifications to the control panel to include the VPAC controller as requested. Choosing the VPAC keeps consistency between control panels in all our existing pump stations. The original contract was \$5,268,000.00 and with Change Order No.1 increasing the amount of the contract to \$5,295,637.81.

INFORMATION: The proposed ordinance is the first amendment to the FY 2026 Appropriation Ordinance, impacting the Street Aid, Sanitation, Capital Projects, Grants and Wastewater Funds and several departments within the General Fund.

Within this budget amendment, the following items are included:

- Reappropriation of funds totaling \$87,535,085 across General, State Street Aid, Capital Projects, Grants and Wastewater Funds,
- Reappropriate and carry forward street paving funds from FY 2025 totaling \$1,500,000 in General and \$773,198 in State Street Aid,
- Rebudget/transfer \$25,000 from General to Grants Fund,
- Budget funds remaining from FY 2024 for Tourism Enhancement Reserves totaling \$542,024,
- Budget funds to match and transfer to Grants (Healthy Built Environment Grant) totaling \$25,000,
- Budget funds remaining from FY 2024 for Firefighters Park Reserves totaling \$27,694,
- Budget transfer from General Fund in Cap Projects totaling \$2,813,008,
- Budget \$160,634 for Equitable Sharing "Justice" proceeds, \$19,261 for Equitable Sharing "Treasury" proceeds, \$51,901 for sales of seized weapons, and \$ 98,165 for Sexual Offender Registry fees in Police,
- Budget \$5,460 for Training Reserves funds, \$10,430 for FY 2025 OEM Reserves funds and \$10,621 for replacing extraction equipment with insurance proceeds in Fire,
- Grants Fund includes \$32,308 for 2023 JAG, \$18,942 for 2024 JAG, \$50,000 for Healthy Built Environment Grant, and \$550,000 for CDBG imminent threat grant for new warning sirens.

The following items are added on second consideration:

- \$39,690 budgeted for Columbia Works improvements at Chasepoint in Streets,
