INFORMATION: The City of Columbia currently has a medical services agreement in place with Maury Regional Hospital. This agreement outlines those services that Maury Regional and its affiliates provide for the City.

These services include pre-employment physicals, post-employment physicals, drug and alcohol screenings, annual physicals for fire department personnel and annual health and wellness screenings for City employees.

Currently, the agreement that the City of Columbia and Maury Regional Hospital have in place is set to expire on December 31, 2025. The new agreement would extend those services through

December 31, 2027.

There are minor increases to the cost of this agreement. However, there are other areas of cost savings within the agreement to offset those increases.

It is recommended that City Council approve this continued partnership with Maury Regional Hospital and its affiliates.

APPROVE AND AUTHORIZE THE MAYOR TO EXECUTE CHANGE ORDER NO. 2 FOR THE FY2024-2025 STREET RESURFACING CONTRACT BETWEEN THE CITY OF COLUMBIA AND VOLUNTEER PAVING FOR MILLING, STRIPING, AND RESURFACING AT THE COLUMBIA AQUATICS & RECREATION CENTER (ARC) IN THE AMOUNT OF \$142,325.33. - DEVELOPMENT SERVICES DEPARTMENT.

INFORMATION: On June 12, 2024 City Council approved and authorized a bid award with Volunteer Paving with an amount Not To Exceed \$4,500,000, for street resurfacing within Wards 1,2,3,4, and 5.

This Change Order will add unit items 9 and 10 which cover all resurfacing, milling, and striping at the Columbia Aquatics & Recreation Center. This Change Order will also increase the Not To Exceed amount from \$4,500,000 to \$4,838,672.05.

INFORMATION: An invitation to bid was properly advertised and solicited for transfer station and landfill services for the City of Columbia. We received two responses for this bid. The low bidder was UDP (Unified Disposal Partners, LLC) at \$54.73 per ton, which is estimated to be \$1,368,250 per fiscal year (assuming 25,000 tons). Council is requested to authorize a three-year bid with two one-year renewal options.

9 RESOLUTIONS.

9.1. RESOLUTION NO. 25-77 - A RESOLUTION AUTHORIZING THE TERMINATION OF THE AUGUST 1994 MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF COLUMBIA AND SATURN CORPORATION, NOW GM - FIRE & RESCUE.

RECOMMENDATION: Approve Resolution No. 25-77.

INFORMATION: November 7, 1985, Resolution No. 85-33 was passed and adopted by the City Council of the City of Columbia, TN and the Industrial Development Board of Maury County, County Commissioners of Maury County, TN, the Town of Spring Hill, Tn, and the Town of Mt. Pleasant, TN entering into an agreement with Saturn Corporation, later General Motors, to establish the Spring Hill manufacturing plant. This agreement included In Lieu of Tax payments (PILOT). The term of this original agreement began January 1, 1986 and was to expire December 31, 2025.

August 31, 1994, the City of Columbia Fire Department entered into a Memorandum of Understanding with Saturn Corporation. This MOU provided for fire protection, emergency response and cooperation between Columbia Fire Department and the Saturn/GM facility.

November 13, 2023, the Termination of original PILOT Documents was approved by the City Council of the City of Columbia, TN.

Pursuant to the August 31, 1994 Memorandum of Understanding, "This Memorandum of Understanding may be terminated by either

party at any time, with or without cause, without penalty, upon (90) days written notice by either party." Therefore, Columbia Fire & Rescue requests City Council's approval to terminate the 1994 MOU between Columbia Fire Department and Saturn Corporation (GM). This will ensure that City of Columbia resources remain dedicated to the residents within the Corporate limits of the City of Columbia, thereby removing financial and operational burdens. Columbia Fire & Rescue will continue to provide automatic aid or mutual aid support to surrounding jurisdictions, including the GM and Ultium facilities, when formally requested through established channels.

This Resolution does not barr the City of Columbia and GM from future negotiations of service.

RECOMMENDATION: Approve Resolution No. 25-81.

INFORMATION: The State of Tennessee Department of Finance and Administration, Office of Criminal Justice Programs, established the Violent Crime Intervention Fund (VCIF) to assist local law enforcement agencies with efforts to reduce and prevent violent

crime.

The Columbia Police Department submitted an application to the VCIF program for consideration of state-allocated funding to support technology upgrades, specialized equipment, and program initiatives that strengthen investigations, improve officer safety, and enhance data-driven crime-reduction strategies.

The State of Tennessee is currently reviewing applications for this funding opportunity. This resolution formally ratifies the submission of the City's VCIF grant application and authorizes acceptance of the grant award, if approved, in an amount not to exceed \$1,300,000.

No local matching funds are required for participation in this program.

10.1.2ND CONSIDERATION FOR ORDINANCE NO. 4562 - AN ORDINANCE CONVERTING FLOW OF TRAFFIC ON SOUTH GARDEN STREET TO ONE-WAY TRAVEL FROM W 11TH STREET TO DEPOT STREET - DEVELOPMENT SERVICES DEPARTMENT.

RECOMMENDATION: Approve Ordinance No. 4562 on second consideration.

INFORMATION: City of Columbia Development Services Department was requested to convert the portion of South Garden Street between West 11th Street and Depot Street to one-way in conjunction with a development project at 1205 South Garden Street. Said development is providing the modifications in-kind, including on-street parking, pavement markings, and necessary signage. This change was unanimously recommended for approval by Columbia Municipal Planning Commission on September 10, 2025.

10.2.2ND CONSIDERATION OF ORDINANCE NO. 4564 - AN ORDINANCE TO AMEND ORDINANCE NO. 4400 –THE SAME BEING THE ZONING ORDINANCE OF THE CITY OF COLUMBIA, TENNESSEE BY ZONING PROPERTY BEING ANNEXED BY RESOLUTION NO. 25-70, LOCATED OFF LASEA ROAD BEING TAX MAP 73 PARCEL 17.02 TO CD-3 (NEIGHBORHOOD CHARACTER DISTRICT)-WARD 5 - DEVELOPMENT SERVICES DEPARTMENT.

RECOMMENDATION: Approve Ordinance No. 4564 on second consideration.

INFORMATION: The applicant is requesting to zone property proposed to be annexed under Resolution No. 25-70 to CD-3 (Neighborhood Character District). The concept plan reflects future development of 31 single-family lots. The Planning Commission reviewed this request and recommended approval by a vote of five to one at the September 10, 2025, meeting.

10.3.2ND CONSIDERATION ON ORDINANCE NO. 4566 - AN ORDINANCE TO AMEND THE COLUMBIA MUNICIPAL CODE BY REPEALING AND DELETING TITLE 12, CHAPTER 1, SECTIONS 12-101, 12-102, AND 12-103, PERTAINING TO THE BUILDING CODE AND ADOPTING NEW SECTIONS 12-101, 12-102 AND 12-103 - CITYWIDE - DEVELOPMENT SERVICES DEPARTMENT.

RECOMMENDATION: Approve Ordinance No. 4566 on second consideration.

INFORMATION: Adoption of the 2024 editions of the International Building Codes. Tennessee state law prescribes municipalities to adopt building code editions that are within seven (7) years of current publication. The International Code Council publishes an

updated code edition every three (3) years. The City of Columbia has previously adopted the 2000, 2006, 2012, and the 2018 editions of the International Building Codes. The current 2018 edition of the International Building Code was adopted in December 2019. The proposed 2024 code editions, with modifications, will be effective January 1, 2026, which is within the directed timeframe.

10.4.1ST CONSIDERATION OF ORDINANCE NO. 4568 - AN ORDINANCE REPEALING TITLE 7, CHAPTER 2 OF THE CITY OF COLUMBIA MUNICIPAL CODE ENTITLED "FIRE PREVENTION CODE" IN ITS ENTIRETY AND REPLACING IT WITH A NEW CHAPTER 2 ADOPTING THE 2024 INTERNATIONAL FIRE CODE, INCLUDING APPENDIX B AND C WITH CERTAIN AMENDMENTS; PROVIDING LIMITED EXEMPTIONS FOR PUBLIC-SAFETY AND INFRASTRUCTURE PROJECTS; AND REQUIRING BUSINESS PORTAL REGISTRATION AND ESTABLISH THE DATE OF DECEMBER 11, 2025 AS THE DATE OF PUBLIC HEARING - FIRE & RESCUE.

RECOMMENDATION: Approve Ordinance No. 4568 on first consideration and establish December 11, 2025 as the date of Public Hearing.

INFORMATION: The City of Columbia is classified as an "exempt jurisdiction" by the State of Tennessee Fire Marshal's Office (SFMO) which means the SFMO has determined we have adequate code enforcement and are permitted to handle most of the projects in the city without SFMO involvement. In order to remain an "exempt jurisdiction" we are required to adopt a fire code that is within 7 years of the latest "published" edition (TCA 68-120-101 (b)(5)(A)). Currently, we have the 2018 Edition adopted. The 2024 International Fire Code is fully compatible with all other International Codes published by the International Codes Council (ICC).

This ordinance adopts the 2024 International Fire Code (IFC), published by the International Code Council, establishing modern

fire-safety standards for the City of Columbia. It retains Appendix B, with a local amendment authorizing Tanker Shuttle Operations (TSO) as an equivalent water supply, and establishes Fire Marshal Standard FM-101 – “Fire-Flow and Water-Supply Requirements.” This standard serves as the City’s technical guide for hydrant spacing, fire-flow minimums, alternative water-supply methods, and required documentation. The standard separates detailed operational requirements from the ordinance, allowing the Fire Marshal and Fire Chief to make timely adjustments as the City’s water system expands, demands increase, or flow capacities improve. This approach ensures technical requirements can evolve without repeated Council amendments, maintaining flexibility while preserving accountability under Columbia Fire & Rescue. 10.8.1ST CONSIDERATION OF ORDINANCE NO. 4572 - AN ORDINANCE AMENDING ORDINANCE NO. 3761 AS PREVIOUSLY AMENDED BY ORDINANCE NUMBERS 3815, 3884, AND 3917 AS IT PERTAINS TO POST-65 SUPPLEMENTAL HEALTHCARE INSURANCE BENEFITS FOR EMPLOYEES HIRED AFTER JUNE 30, 2012 - CITY ATTORNEY'S OFFICE.

RECOMMENDATION: Approve Ordinance No. 4572 on first consideration.

INFORMATION: Employees under the old "Rule of Eighty" retirement plan have an additional benefit regarding retiree health/pharmaceutical insurance.

They enjoy being able to enroll in the City's retiree supplemental plan to Medicare Plan A/B and Plan D (pharmaceutical). It is at no cost to the retiree. Spouses are not included. This is a fully insured supplemental plan (Aetna) and not part of the City's self-insured health plan.

To be currently eligible for the supplemental plan an employee

must:

- Be under the old pension plan.
- Be at least 65 years old.
- Have five years continuous service up to age 65 or beyond; and
- They must be enrolled in the city's self-insured health plan for at least one year leading up to retirement.

Staff has reviewed this and would like to recommend the benefit be extended to all City employees. The eligibility would be based on the same criteria mentioned above.

If this had been in place the last 5 years, 6 employees would have been eligible to enroll. Staff has discussed this with Aetna representatives, and they have indicated there would be no increase to the premium.

This would correct an inequity in employee benefits and help with employee retainage.

This was mentioned to the Trustees Board at their October meeting and there were no objections.
