1. PUBLIC HEARING ON ORDINANCE NO. 4585 (AS AMENDED) – AN ORDINANCE TO AMEND THE FISCAL YEAR 2025-2026 BUDGET ORDINANCE NO. 4544, AS AMENDED, PROVIDING FOR REVISIONS TO THE GENERAL, STATE STREET AID, SANITATION, CAPITAL PROJECTS, GRANTS, AND WASTEWATER FUNDS - FINANCE.

RECOMMENDATION: Conduct the Public Hearing.

INFORMATION: This Public Hearing is related to item 10.1 on the agenda. The proposed ordinance is the fourth amendment of the FY 2026 Appropriation Ordinance and revises the General, State Street Aid, Sanitation, Capital Projects, Grants, and Wastewater Funds.

Supporting documentation for the amendment is included within the agenda packet and the required Notice of Public Hearing was published in Main Street Maury on May 6, 2026.

This amendment increases the City's total budget for FY 2026 by \$15,419,351 from \$184,971,390 to \$200,390,741.

INFORMATION: This ordinance will amend Title 12, Chapter 1 of the Municipal Code as it pertains to the required minimum standards for fire prevention, fire protection, and building construction safety for

government owned buildings. The amendment will establish the standards adopted by the Tennessee State Fire Marshal's Office as the minimum standards for design and construction for all Federal, State, County and City owned buildings inside the City of Columbia. Establishing the State Fire Marshals adopted codes for government-owned buildings will help to reduce jurisdictional conflicts. This amendment will be effective upon approval of second consideration. The required notice of Public Hearing was advertised in *Main Street Maury* on Wednesday, May 20, 2026.

7.3. APPROVE THE CITY OF COLUMBIA'S STOP LOSS GROUP MEDICAL INSURANCE PREMIUM WITH SUN LIFE FINANCIAL WITH AN INDIVIDUAL SPECIFIC DEDUCTIBLE OF \$150,000 AND AN AGGREGATING SPECIFIC DEDUCTIBLE OF \$125,000 EFFECTIVE JULY 1, 2026 AND AUTHORIZE THE MAYOR TO SIGN ANY NECESSARY DOCUMENTS - FINANCE.

RECOMMENDATION: Approve.

INFORMATION: To ensure we are receiving the most competitive rates and the best possible service for our eligible employees; Sherrill Morgan does a request for proposals for stop loss coverage. This plan year our health plan experienced higher claimants than in the previous plan year. The renewal rates for the year beginning July 1, 2026 have a slight increase of 3.7% over the current year by Sun Life.

Sun Life continues to guarantee against any of our employees being subject to an individual laser and that we will not receive an increase above 50%. With this guarantee, the decision was made to stay with Sun Life for the stop loss.

BlueCross BlueShield of Tennessee has a small increase of \$0.11 per month per employee on our administrative fees as this new rate also includes Teladoc; for the 26-27 plan year the fees will be \$55.86 per employee per month. The administrative fee for dental remained at the same rate of \$4.46 per employee per month.

In an effort to improve employee awareness of their current health condition(s), the City will continue the tobacco and HRA/biometric requirements. These requirements do not apply to those employees who are not on the group medical plan and receive the "in lieu of insurance" amount of \$1,700 annually.

7.4. RECEIVE AND FILE COST OF LIVING ADJUSTMENT (COLA) FOR ELIGIBLE RETIREES OR BENEFICIARIES OF THE CITY OF COLUMBIA EMPLOYEES' RETIREMENT PLAN - CITY RECORDER'S OFFICE.

RECOMMENDATION: Approve.

INFORMATION: Each year the cost of living adjustment for eligible retirees or beneficiaries of the City of Columbia Employees' Retirement Plan is forwarded to the Trustees of the City Retirement Plan by the actuarial consultant. The increase of 3.00% of their current retirement benefit is to become effective July 1, 2026 for those retirees or beneficiaries who began receiving benefits on or before July 1, 2025. The City Retirement Plan provides that the cost of living adjustment shall be increased for eligible retirees or beneficiaries each July 1 based on the Consumer Price Index (CPI-U) for all Urban Consumers, not to exceed three (3%) percent. The 3.00% is based on the period from March 31, 2025 to March 31, 2026.

7.5. APPROVE AND AUTHORIZE THE MAYOR TO SIGN A PROJECT AGREEMENT BETWEEN THE CITY OF COLUMBIA AND CHANDLERTHINKS, LLC IN THE AMOUNT OF \$59,500 FOR BRANDING & VISUAL IDENTITY PROFESSIONAL SERVICES - CITYWIDE - CITY MANAGER'S OFFICE.

RECOMMENDATION: Approve.

INFORMATION: The team at Chandlerthinks will lead this Branding & Visual Identity project for the City of Columbia using a phased approach: Research, Strategy, Creative, & Action Plan. Steps include site visit, community perception study, outside perception study, stakeholder interviews, focus groups, digital audit, & brand strategy development resulting in a robust brand that is unique to Columbia. A strong brand and professional image makes the city more attractive to employers, tourists, developers, entrepreneurs, homebuyers, and industries, which can translate into increased sales

tax revenue, property investment, business growth, and broader economic activity.

UTILIZING TIPS COOPERATIVE PURCHASING TO REMOVE AND UPDATE THE OLD ROOF AND REPLACE STORM DAMAGED ROOFS AT THE COLUMBIA AQUATICS AND RECREATION CENTER IN THE AMOUNT OF \$98,460 - PARKS & RECREATION DEPARTMENT.

RECOMMENDATION: Approve.

INFORMATION: The Parks Department recommends approval for a contract with Roof Systems Inc. (RSI) to remove and replace aging roof systems and repair storm-damaged roofing at the Columbia Aquatics and Recreation Center. RSI was selected as a vendor participating through the TIPS Purchasing Cooperative. After evaluating the quote from RSI, City personnel identified that bids would likely have exceeded the quoted price following the purchasing cooperative's preferential pricing.

The proposed work includes replacement of approximately 9,800 square feet of roofing over the indoor poolroom at a cost of \$49,418.00 and replacement of approximately 1,800 square feet of roofing over the pump/maintenance room at a cost of \$49,042.00.

CERTIFICATION: The Chief Financial Officer certifies that \$98,460 is budgeted and unencumbered in Capital Projects - Columbia ARC - Parks & Recreation Facilities.

COLUMBIA AQUATICS AND RECREATION CENTER IN THE AMOUNT OF \$550,000 - PARKS & RECREATION DEPARTMENT.

RECOMMENDATION: Approve.

INFORMATION: Due to the age of the current HVAC system at the Columbia Aquatics and Recreation Center and approaching the end of expected service life, we are in need of replacing these units. Currently, we are experiencing multiple equipment failures and inconsistent temperatures throughout the building. Replacing the current units will greatly improve comfort, improve indoor air quality and reduce downtime associated with repairs as failures happen. Additionally, upgrading the thermostats will improve system communication, scheduling capabilities and alarm monitoring.

CERTIFICATION: The Chief Financial Officer certifies that \$550,000 is budgeted and unencumbered in Capital Projects - Columbia ARC - Parks & Recreation Facilities.

10.1.2ND CONSIDERATION OF ORDINANCE NO. 4585 (AS AMENDED) – AN ORDINANCE TO AMEND THE FISCAL YEAR 2025-2026 BUDGET ORDINANCE NO. 4544, AS AMENDED, PROVIDING FOR REVISIONS TO THE GENERAL, STATE STREET AID, SOLID WASTE, CAPITAL PROJECTS, GRANTS, AND WASTEWATER FUNDS - FINANCE.

RECOMMENDATION: Approve Ordinance No. 4585 as amended on second consideration.

INFORMATION: The proposed ordinance is the fourth amendment to the FY 2026 Appropriation Ordinance, impacting the General, State Street Aid, Solid Waste, Capital Projects, Grants, and Wastewater Funds.

Within this budget amendment, the following items are included:

- Budget/Transfer funds from General Fund (\$1,326,650 from General funds and \$165,000 from Tourism Enhancement funds) to Capital Projects for Communications Equipment (\$36,650), Burn

Box (\$219,000), Drag Machine (sports tourism - \$55,000), Skid Steer (sports tourism - \$110,000), reduce Parks salaries by \$200,000, reduce ARC Machinery by \$400,00 and increase ARC HVAC by same amount, Fire Truck (\$925,000),

- Budget \$144,000 for CPWS and Benchmark increases,
- Haz-Mat payment from Tennessee Southern Railroad (\$7,496.77),
- Neel Schaffer - assessment along Nashville Hwy at Baker Rd & Burt Dr totaling \$20,000,
- Budget 2026 Fire Rescue Squad Grant in amount of \$9,450,
- Budget \$550,000 for Engineering for Pumpkin Creek Project.

On second consideration, the following items are added:

- Budget transfer for Health Plan reserves totaling \$500,000 in the General Fund and \$62,300 in the Wastewater Fund,
- Budget retirement contribution totaling \$500,000,
- Budget transfer to Capital Projects totaling \$475,775 and transfers to Grants Fund totaling \$198,841,
- Budget increase to expenses for General Fund departments totaling \$784,650.00 across,
- Budget increase to expenses for SAN Fund totaling \$455,500,
- Budget increased amount to cover landfill expenditures totaling \$214,664,
- Budget increase and transfer funds to Capital totaling \$459,775,
- Transfer \$540,000 in from bridge project to street paving in the General Fund,
- Budget 2025 CDBG - Drainage Improvements at S. Main and E. 9th Street in the Grants Fund totaling \$946,857,
- Budget amendment No. 4 - Lytle Creek Bridge Replacement Engineering – in the Grants Fund totaling \$16,000,
- Transfer/budget \$1,657,105.51 to/from Capital to General Fund due to FY 25 remaining proceeds,
- Budget transfer for Health Plan reserves totaling \$62,300 in Wastewater,
- Budget increase to expenses for Wastewater totaling \$2,604,991.24.

10.2. 2ND CONSIDERATION OF ORDINANCE NO. 4586 AS AMENDED - AN ORDINANCE FIXING THE TAX RATE FOR THE CITY OF COLUMBIA FOR THE YEAR 2026 ON ALL TAXABLE PROPERTY AT THE RATE OF \$0.6068 PER \$100.00 - CITY RECORDER'S OFFICE.

RECOMMENDATION: Approve Ordinance No. 4586 as amended on second consideration.

INFORMATION: Annually, the City Council adopts the property tax rate via a tax levy ordinance. At the May 14th meeting, the property tax rate was proposed to be carried forward from the previous tax year with no change recommended. 2026 is a reappraisal year for Maury County to complete a countywide reappraisal to include all property within the City of Columbia city limits. The Maury County Assessor of Property has provided the City with the attached *certified tax rate* calculation form. The *certified tax rate* is calculated to produce substantially the same amount of revenue as the prior year, excluding new construction and improvements.

Following City Council approval of the prior year tax rate on first consideration, the tax levy ordinance, Ordinance No. 4586, has been prepared "as amended" to include the new certified tax rate on second consideration. If adopted as amended, the property tax rate would be reduced from \$0.8251 to the certified tax rate of \$0.6068 per \$100.00 of assessed value. This represents a 26.5% decrease in the property tax rate.

The total tax base assessment in 2022 — the last reappraisal year — was \$1,515,041,776.00. This year the total tax base assessment was \$2,425,633,901.00.

10.3.2ND CONSIDERATION OF ORDINANCE NO. 4587 AS AMENDED – APPROPRIATION ORDINANCE FOR FISCAL YEAR JULY 1, 2026 THROUGH JUNE 30, 2027 - FINANCE.

RECOMMENDATION: Approve Ordinance No. 4587 as amended on second consideration.

INFORMATION: Each year, pursuant to the City Charter, the City Council considers the formal adoption of the City budget through an appropriation ordinance for the coming year. The proposed budget was delivered to the City Council at the May 7th study session meeting. The annual budget proposal was presented to Council Members during one-on-one meetings for review of all City departments and funds in advance of first consideration. A Public Hearing is required prior to second consideration and is scheduled for June 11, 2026. Required publication of the tentative Appropriation Ordinance was made in the Main Street Maury newspaper on May 6, 2026. A notice of public hearing including FY 2027 proposed along with current year (2026) and last audited year (2025) budgeted figures was published May 6, 2026.

Since the City Council approved the Appropriation Ordinance on first consideration, an increase in the appropriation for Animal Shelter services of 10%, or \$24,200, has been included for second consideration.

The total proposed budget, all funds, totals \$84,466,601.
